Application Package

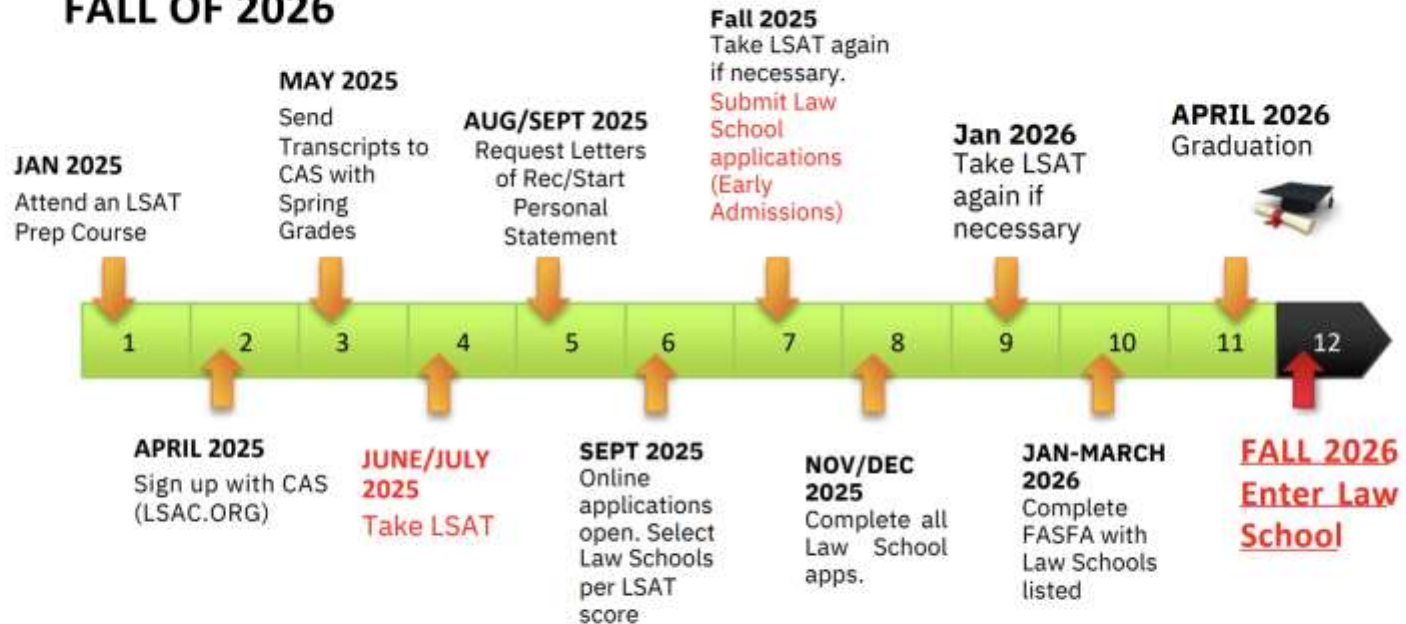
- Transcripts – from all colleges (including Dual Enrollment)
- LSAT score (GRE accepted at some law schools)
- Personal Statement – 2-3 pages
- Resumé
- Letters of Recommendation
- Diversity Statement
- Character and Fitness Addenda

Timeline

- Take a prep-course just prior to LSAT (should start January of your junior year)
- Look to take your LSAT the summer between your Junior and Senior year
- Applications start September 1st of the previous year
- Complete applications by December 31st.
